- Whether the DBE/UDBE/SB firms meet the task order scope of work

PlanetBids Demo is inviting all licensed contractors to submit the following information to the District for inclusion on the District's list of qualified bidders for informal bidding.

The list of contractors will be used according to the Informal Bidding Procedures under the Uniform Public Construction Cost Accounting Act (Section 2200, et seq. of the Public Contract Code) for projects between \$45,000 and \$175,000.

In order to begin the prequalification process with PlanetBids Demo you must meet the following requirements:
