# a. Results of the Student Campus Climate Survey

The committee continued their discussion of the results administration of the NACCC. The data provided some starting points for discussion of how SMC can improve its racial climate and environment for students. A discussion of how to disseminate the findings more broadly across the campus took place, including presenting the complete report or selected findings (depending on the audience) to the Student Equity Center leadership, DPAC, Equity and Diversity Committee, counseling program leaders, student groups, and the Academic Senate. One idea to help departments unpack the rich data (110 survey questions) is to collaborate with the Professional Development Committee to develop guiding questions to be used in department meetings.

## VI. New Business

a. SEAP Metrics

The committee recommends that this year's Student Equity and Achievement (SEA) Annual Report focus on the same metrics and disproportionately impacted (DI)/racially minoritized groups as the previous year's report based on the acknowledgment that it takes multiple years to fully implement activities and make a positive impact on SMC's performance on the metrics. The two metrics (Fall to Spring Retention and Transfer-level Math/English Completion in First Year) were originally recommended as they relate to the early experiences of students. The groups/metrics recommended include:
