Awards Without Petition Initiative (AWPI)



What is AWPI?

- 11 years strong
- Systems analysis to identify graduates automatically
- Uses coursework audits to flag degree/certificate completion
- Limited to students active within last 2 years
- Evaluators review and confirm before conferral

Key Considerations:

- Only one system run per term
- Recognizes impact on federal aid ongoing eligibility
- Degree-eligible on Pell are asked to opt-in to receive degree, but we award certificates
- All other students can **opt out** by notifying evaluator (few do)

Degree and Certificate Petition Deadlines

- Fall Petitions: Start of Fall to December 1
- Spring Petitions: Start of Spring to April 15
- Summer Petitions: Start of Summer to July 31
- Winter Petitions: Start of Winter to January 31 -only for noncredit certificates

• Year-Round: CSU GE, IGETC, and Cal-GETC Certification Petitions
