- d. Climate and Sustainability Action Plan- The Board of Trustees approved funds to hire a consultant to help put together climate action plan.

SMC has expressed and adopted specific climate action goals (as has the Chancellor's office and the state) but we are not meeting them in any organized way and we missing opportunities. Ex: facilities master plan was perfect opportunity to spend bond money in a way that could both save the district money while advances our climate goals, but need expertise to help guide us.

CAP plans to look at every area from water, waste, energy, bldgs, curriculum and asks what are we already doing and what else could we be doing. Gives depts the tools needed to achieve these goals. Having a toolbox as ways to help us achieve these goals is necessary. Ferris has hired a consultant, they will attend a future EAC meeting

Major focus on the committee this year will be to present the plan & get buy in from stakeholders. Identified stakeholders: DPAC, students, administrations- the management associations, CSEA, Senior Staff, academic senate/ FA, epicenter, Adelante, black collegians, Santa Monica community, and finally the Board of Trustees. Timeline is critical (May 2026), it's important to see that we cannot separate climate issues from equity, they are intertwined.
