- 3. Assist SMC faculty in an effort to build a greater sense of belonging and community for racially marginalized students at SMC. Coordinate with goal 9 of the campus-wide "Over arching goals of the Re-Design Efforts."
- 4. Identify and advocate for student-facing technology that will support our student's educational goals. Coordinate with goal 6 of the campus-wide "Over arching goals of the Re-Design Efforts."
- 5. Provide input and collaborative support as needed to various equity-related groups, committees, and initiatives at SMC.
- 6. Update Toward Equity: An Interactive Guide for SMC Faculty. Include information on zero cost textbooks and OER resources.
- 7. Support continued efforts to establish and staff a Gender Equity/Social Justice Advocacy Center.
