- Review of the self-evaluation form
  - Form has been around for many years but wide variance across departments, particularly with FT, tenure-track faculty. Form is often confused with plan for professional development.
  - What is the relationship between the 2 documents?
  - Completed at the end of the fall semesters.
  - This form is being focused on primarily in response to NI evaluation for PT'ers. Contractual issue (albeit relatively new).
  - Pedagogy is conspicuously absent. Needs to be included.
  - Category- maintaining subject matter currency seems to include items not relevant to that category (e.g. membership in a prof association, curriculum dev)
  - How and where to integrate racial equity. Separate category? Integrate or include a sub-item across all categories?
  - Need PT committee voice and input. Steph to ask to attend PT committee meeting and/or invite Cathy Matheson to meet.
  - No clear set of criteria that faculty and observers have agreed upon
  - Need support of dept chairs. This will help advance this.
  - Sara has compiled exemplar self-evaluations to distribute. Review before next meeting in preparation for discussion.
