VI. Old Business:

a. Academic Senate Equity and Redesign Goal: update statement that was created to provide a guiding goal for the work of the Academic Senate for the 2022-2023 year.

<u>Original Statement:</u> Close the gap in student outcomes for Black and Brown students according to the Santa Monica College Equity Plan and promote a culture of equity in the classroom and workplace.

<u>Revised Statement:</u> Develop and implement strategies to close the equity gap for Black and Latinx students according to the SMC Equity Plan and institutionalize racial equity practices in the classroom and workplace.

The Committee discussed usage of the word "Latinx" vs. "Brown" and if one was too specific and one too general. It was noted that "Latinx" is used in the SMC

Equity Plan as well as a descriptor in Precision Campus. Steph Anderson will reach out to the Latinx Collective as well as to Adelante to include their input on this descriptive language. Chanté DeLoach suggested including a footnote regarding our choice of language regardless of which descriptor is used.

The use of the word "institutionalize" was discussed in regard to it being viewed as an infringement on academic freedom. The Committee decided to leave the word and await feedback from the Executive Senate. The use of a footnote to further detail what is meant by the word institutionalize was also discussed.

Steph Anderson will present the above revised version at the next Executive Senate meeting to seek their input.

b. Faculty evaluation redesign: Peter Morse (President of FA) will decide who will serve on the committee to assist with the redesign of faculty evaluation. He has met with Academic Senate President Jamar London who has recommended that Steph Anderson serve on the Committee.
