 - o AR 3400 series: Committee also discussed the AR's in the 3400 series, specifically the AR for Administrative evaluations and whether or not input from the faculty should be provided in these evaluations for the Vice-Presidents and Superintendent/President. Although faculty input is allowed for in AR 3420 Evaluation of Management Personnel, it was stated that, for VPs and the President, there is a need to identify an appropriate faculty cohort from which a random sample could be taken, thereby providing anonymity for the evaluators. Furthermore, the current policy states that a faculty evaluation must be submitted to the administrator/manager's evaluator, which has the effect of making faculty evaluations threatening to people rather than helpful, which is the intent of requiring faculty input as a means of fostering the professional development of our top administrators. Feedback/comments would only be viewed by the evaluatee. It was stated that perhaps there just needs to be more of an awareness that language already exists in the current regulation. It was also announced that a task force has been formed to address and update the

management evaluation AR. It was also stated that an evaluation instrument should be developed to provide feedback to the higher level of management.
