Student Affairs Committee Minutes Wednesday, October 28, 2015

- 1. Call to order 1:00 pm
- 2. The committee voted unanimously to approve the minutes from September 23, 2015.
- 3. Old Business
 - a. AR 4342 Standards of Student Success Probation and Disqualification, AR 4332 Progress Renewal, AR 4210 F-1 International Students' Visas and AR 4210.1 Other Temporary Nonimmigrant Statuses all passed the first full read at the Academic Senate.

4 New Business

- a. AR 4342 Standards of Student Success Probation and Disqualification
 - i. Beatriz asked that the committee consider updating this AR to allow for a student to remain three semesters on probation before they are considered disqualified rather than the current two semesters. Beatriz stated that three semesters are allowable per Title 5. She also mentioned that with SSSP funding we will have greater resources to target and assist these students before they are disqualified.
 - ii. Karen mentioned we cannot compel students to come in when they are on probation, but disqualified students must see a counselor to enroll in classes. Karen feels it is beneficial for the students to have to come to meet with a counselor to address their needs sooner rather than later.
 - iii. Alicia also mentioned there is already a provision in the AR that students can petition to enroll when they are considered disqualified.
 - iv. Beatriz also asked the committee to consider standardizing the percentage of successful course completion required for students enrolled in under 12-30 units verses over 31 or more units. By a vote of 7 to 2, with one abstention, the Committee voted against changing the current percentages used to define timely progress.
 - v. The committee suggested that plans still get developed to target these students, but to hold off on any further changes to this AR right now.

b. AR 4332 Progress Renewal

- i. This AR was updated to reduce from two year wait time restriction currently required to one year to file for progress renewal.
- 5. Alex requested that the committee consider how they define the scope and function of the Student Affairs Committee given the pending bylaw review.

1. Call to order 1:15 pm

2. Old Business

- a. AR 4210 F-1 International Students' Visas and AR 4210.1 Other Temporary Nonimmigrant Statuses both passed the second read at the Academic Senate.
- b. AR 4342 Standards of Student Success Probation and Disqualification
 - i. Alicia brought in a summary sheet on behalf of Beatriz Magallon, outlining what several California Community Colleges with over 10,000 students are using as their guide for progress probation. Most of the colleges are placing students on progress probation when 12 or more units are attempted and W", "I" and "NC" or "NP" units reach or exceed 50%.
 - ii. Esau noted that Santa Monica College is not like other colleges in that we have a much more lenient Progress Renewal Administrative Regulation, and that needs to be taken into account when considering loosening up our guidelines for progress probation.
 - iii. The Committee maintained that they are against changing the current percentages used to define timely progress.

3. New Business

- a. The committee voted unanimously to approve the Scope and Function of the Student Affairs (Joint Committee) as it is currently stated.
- b. The committee voted unanimously to approve AR 4111.5 Transfers from Other Colleges, with the clarification that student must file transcripts of all previous college work.
- c. AR 4410 Rules for Student Conduct
 - i. This AR was updated to reflect the extended language related to sexual assault and violence that was recently incorporated into ED code 76033 and 76034 through the recently passed Senate Bill No.
 - ii. For clarification purposes, Esau requested the Rules for Student Conduct section regarding forgery, alteration, or misuses of college documents, records, or identification also be updated to include some specific behavior that has recently become a problem at Santa Monica College. Specifically this section was updated to include the misuse or misappropriation of add codes, or the enrolling of students in classes with the intent to sell the seat.
 - iii. Deyna is going to share the Committees' revisions with Lisa Winter and Bob Myers.
 - iv. The Committee voted unanimously to approve the changes made to AR 4410.
