The Committee discussed a list of administrative regulations presented by Alexandra and Esau that need to be reviewed/updated. Alicia requested that we also review two other ARs. Volunteers were solicited to lead the effort to draft revisions. Subcommittees were also formed for some ARs.

7. AR 4210 (F-1 International Students /4210.1 (Other Temporary Nonimmigrant Statuses)

These administrative regulations were presented to the Committee for consideration. Esau noted that the primary reason for updating the ARs is because the Federal government has now made it possible for individuals with F2 status in the United States to be admitted to colleges to undertake a program of study so long as they attend part-time. F2 individuals are a spouse or dependent of a F1 status student. The Committee reviewed and updated the two ARs and recommended we forward them to the Academic Senate for consideration. Esau will also forward to Senior Staff for input.

8. AR 4440 (Academic and Extracurricular Trips)

Alexandra presented a proposal to revise the administrative regulation. The revisions clarified the applicability of its provisions to academic field trips. The Committee reviewed and updated the AR and recommended we forward them to the Academic Senate for consideration. Esau will also forward to Senior Staff for input.
