The IEC has completely redesigned the new student seminar experience. During Covid, the new student seminar was offered through remote modalities out of necessity. Upon SMC's return to on-ground instruction, the International Education Center chose to continue to offer the new student seminar online. The online modality allows students to complete the pre-enrollment steps, the seminar itself, and to meet with our international counselors, much earlier than the on-ground seminar offered in the past. The earlier completion of the pre-enrollment steps, the seminar, and the subsequent counselor appointments allow students to enroll in courses as soon as their enrollment dates came to pass. As a result, our international student admission to enrollment yields have increased substantially.

Explore Means to recruit New Students Remotely - In response to travel restrictions resulting from the COVID pandemic, the IEC under the leadership of Denise Kinsella, successfully participated in Dozens of remote recruitment fairs across established and developing markets. These remote recruiting opportunities helped the IEC to slow the enrollment declines during the height of the COVID pandemic. As the pandemic waned, remote recruitment opportunities decreased and in-person recruitment travel resumed with plans to increase recruitment travel up to 9 trips per year.

In Spring 2021, a new ESL Guided Self-Placement (GSP) test was implemented to replace the computer-based ESL assessment test. Like with any transition, students had many questions on how to navigate this new format. IEC Counselors and staff noted an increase in questions related to this issue and responded immediately with additional targeted assistance. IEC Administrators and staff developed Pre-enrollment Zoom Help Sessions for students navigating through the pre-enrollment requirements which included their GSP. Counselors developed a short GSP video which briefly explains what GSP is and how students should approach this process. It explains how students should navigate through the math GSP depending on their selected major and goals. Many students have also taken advantage of one-to-one Zoom Express Counseling sessions to address any lingering questions or concerns.


It has not been possible to complete this objective to an acceptable standard over the past year due mainly to significant budget cuts that have limited the number of counseling hours available to successfully implement this initiative. Initially, the intent was to identify factors based on Institutional Research's data that would help us identify "buckets" of F-1 student cohorts who would be most inclined to experience academic difficulties besides just using GPA predictors. Due to budget constraints and the prioritization of providing basic counseling services, we have been unable to take on this additional project for the time being. This project was put aside for now and will need to be readdressed once budgets are sufficiently restored to allocate the additional resources needed to support the initiative.

Currently, International students referred to our department for academic support services receive an immediate response on how to reach a counselor as well as immediate connection to campus based academic support services.

IEC Counselors are fully on board with the Counseling Department's Guided Pathways initiative. This model by which colleges will help new students explore programs, consider possible careers and develop academic plans to achieve their goals is critical for F-1 students who are here for a limited time, are paying non-resident tuition and may not be familiar with the broad range of majors.

IE Counselors attend the same training meetings as members of the general Counseling Department. IE Counselors have been assigned to the various major groups for training on their roles to become "experts" for those major groups.

2. Considering your program's past plans and the developments over the past two years, what challenges and concerns need to be addressed in the next two-year review period?

Enrollment continues to be of central concern. In 2023-24, international student enrollment continued to trend upwards. international student head count increased by an average of 10% and unit enrollment increased by 11%. The IEC in collaboration with Academic Affairs is also managing a newly developed large-scale Contract Education Program with Novel Prep that will bolster enrollment and infuse needed revenue for the district.

Overall, IEC is experiencing a rebound in new applications and there are some limited but positive indicators that the upward trend in enrollment is likely to continue through fall 2024 and spring 2025. The IEC has focused its resources to augment our admission team to ensure that the increase in applications can be managed effectively and efficiently.

While demand for international education is increasing, the IEC faces significant staffing and course offering challenges to converting increased demand into enrollment over the next year. The irregular distribution of on-ground/hybrid offerings, specifically in high demand majors, will adversely impact our ability to recruit and retain international students who must comply with federal on-ground enrollment mandates. In addition, our ability to fill currently vacated positions on our admissions team during a district-wide hiring freeze will determine our capacity to increase admissions and enrollment yields in upcoming enrollment cycles.

3. Broadly discuss the most critical resources you anticipate needing to effectively implement the goals in your program's action plan in the next review period. If applicable, your answers here should inform the specific line item requests in your future Annual Resource Requests (ARR).

A described above adequate staffing will be of paramount import. Additionally, SMC on-ground and hybrid course offerings need to expand to accommodate federal regulations that require international students to enroll in 9 on-ground/hybrid units to maintain F-1 status. Business and Computer Science are the two most popular fields of study accounting for over one half of our enrolled students. Since returning to on-ground instruction, majors in the business field have consistently offered less than 20 on-ground/hybrid sections per semester. Computer Science and related majors have offered even fewer on-ground/hybrid course options. If these trends continue, currently enrolled students will be forced to transfer to institutions that offer a larger selection of on-ground and hybrid courses, and we will no longer be able to admit new students into majors that do not meet the federal government's criteria for full time enrollment. These trends will severely impede our ability retain our current students and to recruit new students to SMC.
