Estela received notification that, while originally the CCNs were supposed to be automatically approved for UC and their applicable Cal-GETC areas (as their formerly versions were), instead all CCNs must be submitted for UC and Cal-GETC review and approval.

While all CCNs were submitted for Cal-GETC and approved (except POLS C1000 due to a technical error which has been submitted for re-review), they must also now be submitted separately for UC approval in June.
