V. Chair's Report

- META is updated to show specific hours-based unit calculations on the course outline of record. Ex: a course with 2 lecture hours, 3 lab hours will display Total Units: 3; Lecture Units: 2; Lab Hours: 1.
- The Curriculum 2025-2026 Priorities were accomplished or are in progress:
 - Updating CORs to incorporate IDEAAS – Redelia is working with the Senate on consistent equity messaging and acronyms to be used across the college to integrate in curriculum
 - Deactivation of outdated courses – we've discussed deactivations with the curriculum

- committee and department chairs, and used the feedback to draft on a deactivation policy, which is listed on today's agenda
- Submit ADTs using the new Cal-GETC TMC templates: this project is in process. We've filled out the templates and will soon be reaching out to department chairs and curriculum representatives with more information/needed updates.
- Curriculum for program review departments – all departments going through program review either brought forth or are working on curriculum updates
- Asian American & Pacific Islander Heritage Month (APIDA) features on Patsy Takemoto Mink and Mabel Ping-Hua Lee are highlighted in the Canvas shell.

VI. Information Items

1. CCN Updates

No updates from ASCCC or the Chancellor's Office. Assembly Bill 2236 (Berman) is on the floor on the third read, so anyone can call a vote. At this point, most bills are likely to pass.

2. TOP to CIP Project Updates

The Chancellor's Office has confirmed the TOP to CIP crosswalk changes are finalized, but it will take another 7-10 days to publish. Once the finished crosswalk is published, we'll be downloading the TOP to CIP details for each department and sending those out to chairs and curriculum representatives.

3. Cal-GETC Updates

Due to the high number of Common Course Numbering History courses denied for the CSU American Institutions requirement, reviewers from the CSU Chancellor's Office will work with affected colleges over the summer to provide additional feedback. We can only submit for review once a year. When the CCN courses are denied for Cal-GETC, we have a two year phase-out period to resubmit and re-obtain Cal-GETC approval. So far all courses submitted for both Area 3B and Area 4 (which some courses obtained under IGETC – ex: History) have been denied for at least one area. In conversations with other colleges, all courses submitted for multiple areas are only being approved for one area. Ethnic Studies courses are the exception and can be approved in both Area 4 and Area 6.
