V. Discussion Items

a. DE Curriculum Approval Process/Equity/Professional Development Because of the move to online instruction, there are a number of courses being offered remotely that have not gone through the distance education curriculum process. There has been no official word on whether or not the campus will re-open for fall 2020 but given the health and safety protocols necessary to do so, it is very likely that instruction and student services will continue remotely.

As such, in order to remain compliant with Ed Code, those courses will need to move through the distance education curricular process by December 2020. Questions about synchronous/asynchronous instruction with regard to equity as well as the meaningful distinctions between instruction methods and faculty choice will continue to be addressed.

b. Faculty Hiring and Ranking Process

The seven faculty members were hired in spring and will begin in the fall. Three more are waiting for their 2nd interview and another nine are still in the paper screening process. To ensure that accurate data analysis during this time can inform the process, next year's hiring and ranking will not begin until June 2021.
