- i. [Proposed Text](#)

Proposed changes to Title V include changing Academic Probation and Dismissal to Academic and Progress Notice and Pause and replacing references to being placed on Academic Program with Academic Notice. Additionally, there is an ongoing discussion on standardizing academic renewal statewide. The Chancellors' office will be accepting public comments on the issue until October 17th.

IV. Discussion Items

a. Action Items vs First and Second Reads

Discussion continued about the pros and cons of 1st/2nd reads versus Action Items. While 1st/2nd reads allow for more discussion of an item, they also lengthen the process for approval. Action Items allow for Exec to discuss an item and Table it if necessary for further discussion/return to committee or approve it without the need for a second read before being sent to Senate for final vote. The committee expressed support for the Action Item option and approval of its implementation will be agendaized for the next Senate.

b. Student Relief Fund

Follow up discussion on re-establishing the Student Relief Fund after receiving support at the last Senate meeting. Further discussion is needed on comprehensive implementation so that the students the funds are intended for receive them in a timely manner.

c. ASCCC Visit

ASCCC recommends a campus visit every 3 years which provides local senates with an opportunity to receive professional development and/or technical assistance. After discussion the committee expressed an interest in receiving for information/education on Area 10 of the 10 + 1 (Institutional Planning and Budget).

a. Review Draft Goals (V. Arrizon)

A final review/editing of the 2025-26 Senate Goals. AB 1705 was tabled and will be discussed after a scheduled meeting with the ESL, Math, and English departments. It is suggested that we move forward in creation of an ad-hoc Senate committee. There were also additional language changes to the remaining Goals.

b. AR 5010 Admission Eligibility; AR 5013 Residency Determinations for Military/Dependents; AR 5020 Nonresident Tuition/Exemptions; SAC Scope & Functions (B. Magallon)
