- a. Review Draft Goals (V. Arrizon)
- i. The current draft 2025-2026 Senate Goals was discussed at length. Substantive changes regarding language that are in line with the purview of the Senate were made with an emphasis on strengthening communication and collaboration between the Senate and the campus at large. There was desire for more collaboration and communication between English, Math, and ESL as noted in the draft goal for an ad-hoc committee.
