a. AR 4235 Credit for Prior Learning (B. Magallon)

Magallon presents revisions to this AR, which is being updated because the state is directing us to add language regarding credit for prior learning. There is currently little guidance concerning procedures for evaluating certain categories of credit for prior learning, such as credit for student-created portfolios. A subcommittee will be ironing out details. The regulation attempts to avoid imposing fees, especially for students who qualify for the Promise Grant.
