SUBJECT: JOINT STUDY SESSION BETWEEN SANTA MONICA-MALIBU UNIFIED SCHOOL

The Santa Monica-Malibu Unified School District (SMMUSD) and the Santa Monica Community College District (SMC) continue to build on the history of collaboration to prepare students for successful postsecondary education by sharing resources, and executing the objectives of the Memorandum of Understanding (MOU) which the two districts entered into in May 2007. The hallmarks of the partnership include promoting excellence in equity through the dual enrollment program, summer programs for high school students, shared use and development of facilities, and the collaboration and articulation of precollegiate preparation and career and technical education coursework. In addition the staff of both institutions work collaboratively to enhance existing programs and create new opportunities for students.

During this study session, the participants reported on the outcomes of activities related to the goals identified at the 2015 Joint Board meeting: (1) promoting college readiness and success, and (2) expanding and utilizing dual enrollment as a tool to develop pathways to college and careers. In addition an update on the development of the new SMC Malibu campus will be provided as well as a report on potential new joint use projects. Members of the SMMUSD Board of Education, SMC Board of Trustees, and staff and faculty from both institutions will engage in data-driven discussion of progress toward meeting mutual goals, what can be learned from current activities to improve, as well as next steps in this important collaboration to ensure SMMUSD students engage and succeed in postsecondary education.

Staff from the school district and college answered governing boards' questions regarding: freshmen placement in English and math statewide; plans to work with the high school principals, counselors, and advisors to increase the number of students taking either English AP courses or the ERWC course during their senior year; the minimum qualifications an SMMUSD teacher must meet in order to teach an SMC dual enrollment course; plans to support Young Collegians through the year, including the summer months; aspects that have contributed to the success of the dual enrollment program; how counselors and advisors could improve outreach to students of color; and details related to the bachelor's degree in interactive design, including enrollment numbers and the possibility of offering related courses under dual enrollment.

The governing board members requested information regarding: post-secondary school activities, other than enrolling at SMC; matrices for next year's presentation measuring college readiness based on outcomes from this school year as well as the academic success of Young Collegians; information on Young Collegians related to degrees earned, transfer rates from SMC to four-year universities, and the possibility of offering a free SMC experience for SMMUSD students; data on academic performance of SMMUSD students once they enroll at SMC; a copy of the previous Memorandum of Understanding for dual enrollment; and the demographics of students enrolled in the interactive design baccalaureate program.
