IV. SUPERINTENDENT'S REPORT

28th Annual Student Photography Winners: Photography professor Larry Jones presented the winners of the 28th Annual Student Photography Show winners to the Board of Trustees. Updates:

- Marketing Program: Senior Director of Government Relations and Institutional Communications
 Don Girard reported that with summer enrollment figures strong up 18.5 percent over 2005 and
 7.5 percent over 2006 the college continues to look at new methods of marketing and
 advertising. Aside from radio and print advertising (including ethnic press such as La Opinion, L.A.
 Sentinel and Korea Times), the college will begin new forms of advertising, including radio
 commercials that invite text message responses from prospective students; and new web search
 techniques on Google.
- The Music Department will move into the renovated Madison campus this summer to begin classes in the fall.
- Vice President of Human Resources Marcy Wade reported that the college plans to interview candidates for the currently vacant Vice President of Business and Administration position at the end of June, with the position expected to be filled by September 1st. She also reported that recruitment continues for the recently created General Counsel position.
- Vice-President of Student Affairs Robert Adams has been named the new President of Merritt
 College in Oakland. He plans to assume his presidency at Merritt College in July. Dr. Adams was
 thanked for his many years of service and for his leadership in building a wonderfully strong team in
 student services at Santa Monica College.

APPROVING DEDICATION OF AN EASEMENT TO THE CITY OF LOS ANGELES FOR A TRAFFIC SIGNAL FOR

THE BUNDY CAMPUS

SUBMITTED BY: Superintendent/President

REQUESTED ACTION: It is recommended that the Board of Trustees adopt the following

resolution:

WHEREAS, Education Code Section 81310 authorizes the Board of Trustees of the Santa Monica Community College District to dedicate an easement to another public entity for public street or highway purposes,

WHEREAS, the Bundy Master Plan includes the construction of a traffic signal to provide safe ingress into the Bundy Campus from the northeast corner of the property,

WHEREAS, to facilitate the construction of the traffic signal the City of Los Angeles requires the dedication of an easement over property of the District adjacent to 3171 South Bundy Drive,

WHEREAS, this Board, on May 14, 2007, adopted its Resolution of Intention to Dedicate to City of Los Angeles an easement for public street purposes over, along, upon and across that portion of real property in the City of Los Angeles, County of Los Angeles, State of California, belonging to said District,

WHEREAS, said Resolution of Intention provided that a public hearing on the question of making such dedication be held by this Board at its regular place of meeting on June 11, 2007, at 7:00 p.m., at which time and place all persons interested might appear and show cause, if any they have, why such dedication should not be made.

WHEREAS, the notice of the adoption of said Resolution of Intention was duly given as provided by law all of which appears by the affidavits of posting and publication on file in the office of this Board,

WHEREAS, this Board formally convened at the time and place set forth in said Resolution of Intention, and no petition protesting against the proposed dedication signed by 10 percent of the qualified electors of the District was filed with this Board at or before the meeting,

WHEREAS, in the judgment of this board, it is expedient and for the best interests of this District that said dedication be made,

NOW, THEREFORE, the Board of Trustees of said District hereby approves the dedication to City of Los Angeles an easement for public street purposes over, along, upon and across that portion of real property in the City of Los Angeles, County of Los Angeles, State of California, belonging to said District, and more particularly described as follows and in Exhibit "A":

THE SOUTHWESTERLY 2.00 FEET OF THE NORTHEASTERLY 12.00 FEET OF LOT 1 OF TRACT NO. 17636 IN THE CITY OF LOS ANGELES, COUNTY OF LOS ANGELES, STATE OF CALIFORNIA, AS PER MAP RECORDED IN BOOK 482, PAGE 33 OF MAPS, IN THE OFFICE OF THE COUNTY RECORDER OF SAID COUNTY.

BE IT FURTHER RESOLVED that the Superintendent/President is authorized to sign the dedication agreement set forth in Exhibit "A".

COMMENT:

One of the steps in constructing a traffic signal at the Bundy Campus is to dedicate an easement for public street purposes over a small portion of the District's property adjacent to Bundy Avenue. California Education Code Sections 81310 through 81315, Dedication of Real Property, authorizes the District to dedicate an easement to another public agency without consideration for public street or highway purposes. At its May 14, 2007 meeting, the Board of Trustees, by a two-thirds vote, adopted a resolution of intention to make the dedication. Notice has been given by publication and posting as required by law. This resolution approves the property dedication.

SUBJECT: FIRST READING - BOARD POLICY 2440, SMOKING ON

CAMPUS

SUBMITTED BY: Superintendent/President

REOUESTED ACTION: It is recommended that the Board of Trustees conduct a first reading of a

proposed revision to Board Policy 2440 - Smoking on Campus.

BP 2440 Smoking on Campus

Smoking shall not be permitted in any District building, vehicle or facility, or within 25 feet of any main exit, entrance or operable window of a public building. Smoking shall be permitted in any outdoor areas except where

prohibited.

Smoking shall be permitted in designated areas of the campus only.

Reference: California Government Code Sections 7596-7598

COMMENT: At its meeting on May 16th, the District Planning and Advisory Council voted

to support a resolution for a smoke-free campus, proposed by the Associated Students as a result of the recent student election. The language of the policy will allow for an implementation strategy to facilitate enforcement beginning Fall 2007. Restricted smoking areas will be designated on campus in compliance with California Government Code Sections 19994.30 and 19994.33 (no smoking with 25 feet of college buildings) and follow the model implemented by the City of Santa Monica. It is important to have designated smoking areas on campus so that the surrounding neighborhood sidewalks will not become the unintended smoking areas. The

implementation will be reviewed in spring 2008.

SUBJECT: FIRST READING - BOARD POLICY 2210

PARTICIPATORY GOVERNANCE, ACADEMIC SENATE

SUBMITTED BY: Superintendent/President

REQUESTED ACTION: It is recommended that the Board of Trustees conduct a first reading of a

proposed revision to Board Policy 2210 - Participatory Governance,

Academic Senate

<u>COMMENT</u>: Based upon a recommendation of the Academic Senate, the proposed

revision to Board Policy 2210 in the section <u>Powers</u> would have the Board rely primarily upon the advice and judgment on the Academic Senate in the area of Grading Policies. Grading policies currently fall within those academic and professional matters subject to mutual agreement through the

joint committee structure of the Academic Senate and the District.

BP 2210 Academic Senate

The Board recognizes and endorses the rights and responsibilities assigned to faculty by Assembly Bill 1725 (1988) and in order that the faculty may have formal and effective procedures for participating in the formation and implementation of District policies on academic and professional matters, an Academic Senate is hereby established at Santa Monica College.

The Board recognizes the Academic Senate (The Senate) as the body which represents the faculty in collegial governance relating to academic and professional matters. The Academic Senate President or designee shall be accorded an opportunity on the Board's regular agenda to address the Board regarding its concerns. The Board of Trustees shall consider and respond to such views and recommendations.

Formation, Procedures, Membership

The Board of Trustees of the Santa Monica Community College District hereby authorizes the faculty of the college to:

- I. Fix and amend by vote of the faculty the composition, structure and procedures of the Academic Senate.
- 2. Provide for the selection, in accordance with accepted democratic election procedures, of the members of the Academic Senate.
- 3. Provide for the membership of part-time faculty members in the Academic Senate.

Powers

The Board Shall rely primarily upon the advice and judgment of the Academic Senate in the areas listed below. Rely primarily means that the recommendations of the Academic Senate will normally be

accepted and only in exceptional circumstances and for compelling reasons will the recommendations not be accepted.

- 1. Faculty roles and involvement in accreditation processes, including self-study and annual reports;
- 2. The assessment of faculty professional development needs;
- 1. Grading policies.
- 2. Faculty roles and involvement in accreditation processes, including self-study and annual reports;
- 3. The assessment of faculty professional development needs;

If a Senate recommendation in the above areas is not accepted, the Board or its designee shall promptly communicate its reasons in writing to the Senate.

The process for mutual agreement shall be used for all other academic and professional matters and shall occur primarily through the Academic Senate's joint committee process. Mutual agreement means that the policy and implementation recommendations shall be prepared by an Academic Senate joint committee and/or the joint Education Policies Committee of the Academic Senate and ratified by the Academic Senate and the Superintendent/President.

- I. The Board of Trustees designates and directs the Superintendent/President or designee to meet and confer with representatives of the Academic Senate with respect to recommendations made or proposed to be made by the Senate.
- 2. The list of academic and professional matters which are to be resolved by mutual agreement, includes but is not limited to:

B. Grading policies

- A. Curriculum, including establishing prerequisites and placing courses within disciplines.
- B. Degree and certificate requirements.
- C. Educational program development
- D. Standards or policies regarding student preparation and success.
- E. District and college governance structures, as related to faculty roles.
- F. Policies for faculty professional development activities.
- G. Processes for program review.
- H. Processes for institutional planning and budget development.
- I. Policies for academic personnel matters.
- J. Other academic and professional matters as mutually agreed upon between the Board of Trustees and the Academic Senate.
- 3. The Educational Policies Committee consists of Senate Executive Committee members and senior staff.
- 4. The structure and composition of the Academic Senate joint committees will be based on the tradition of joint committees at the college. Each Academic Senate joint committee shall be constructed as follows:
 - A. Faculty members shall be appointed by the Academic Senate.
 - B. Administrators shall be appointed by the Superintendent/President.
 - C. The committee chair shall be a faculty member appointed by the Academic Senate President after consultation with the Superintendent/President or designee.
 - D. The committee secretary shall be an administrator appointed by the Superintendent/ President or designee after consultation with the Academic Senate President.
 - E. All Academic Senate joint committees shall be comprised in such a manner so that the ration of the faculty appointees to administrative appointees is approximately 2:1.

- F. The Academic Senate the Superintendent/President shall mutually agree on the addition of any classified staff and students to the designated joint committees.
- 5. If, within one month, during the Fall and Spring semesters when the Academic Senate is in session, either party fails to ratify the policy development and implementation recommendation, the Academic Senate President and the Superintendent/President shall decide, within ten working days from the date, which of the following options shall be used to resolve the impasse.
 - A. Send the recommendations back to the committee of origin and direct them to develop a new recommendation.
 - B. The Academic Senate and the Superintendent/President shall both delegate their ratification authority to the committee of origin and the committee's final recommendation shall become the recommendation on the issue.
 - C. The Academic Senate President and the Superintendent/President shall resolve the issue independent of the committee of origin.
- 6. The Senate reserves the right, after consultation with the administration, to present its concerns and recommendations directly to the Board and the Board shall respond to the Senate.
- 7. District standing committees (e.g., budget advisory committee, coordinating council, matriculation advisory committee, staff diversity/affirmative action advisory committee) shall be structured to include appropriate representation of the Academic Senate, administrators, and classified staff when matters being considered are within their purview. Student representation shall be included on such groups whenever appropriate and possible.
- 8. The appointment of faculty members to serve on college or District Committees, task forces, or other groups dealing with academic and professional matters shall be made by the Senate, after consultation with the Superintendent/President or designee.

Duties Assigned by Administration and the Board of Trustees

The Academic Senate may assume such responsibilities and perform such functions as may be requested of it by the administration or by the Board of Trustees.

Scope of Regulations

Nothing in this Board policy shall be construed to impinge upon the due process rights of faculty, nor to detract from any negotiated agreements between collective bargaining representatives and the Board of Trustees.

It is the intent of the Board of Trustees to respect agreements between the Academic Senate and the Faculty Association as to how they will consult, collaborate, share or delegate among themselves the responsibilities that are or may be delegated to the Academic Senate pursuant to these recognitions.

A new summer outreach program was successfully launched last summer with two 6-week forcredit courses offered to high school students. The grant paid for the books, and transportation to a field trip to NASA JPL in Pasadena, CA. Two project management principles in-house training sessions were successfully conducted to train the CSIS faculty on the basics of Project Management Principles and Microsoft Project 2003. These sessions helped spark interest in this area, and more faculty plan to update their curriculum to include this important topic. Finally, a scholarships program was also successfully implemented to identify and award scholarships to students according to the grant criterion. The grant passed all year one requirements and was awarded \$124,999.00 for year two.

The 2005-2006 fiscal year closed with an Unrestricted General Fund ending balance of \$8,385,633.

GENERAL FUND

General Fund Unrestricted Revenues (01.0)

These are the only funds available for the general operations of the College. All other funds are restricted.

The proposed California Community College System budget for 2007-2008 provides for a Cost of Living Adjustment (COLA) of 4.53%. COLA is applied only to about 70% of the SMC General Fund revenue. Projections are based upon information received in the Governor's "MayP Revise" figures. Santa Monica College does not anticipate any growth funding for fiscal year 2007-2008.

The state funding formula is based on the combination of property taxes, enrollment fees and principal apportionment funds added together to equal the estimated State General Revenue. The figures in the tentative budget are based on estimates from the Chancellor's Office adjusted by the District's enrollment projections. The District is still awaiting the receipt of the official P2 report and the Advanced Apportionment report and therefore adjustments to revenue should be anticipated between the tentative budget and adopted budget. If actual receipts of either property taxes or enrollment fees differ from projections, principal apportionment funding will be adjusted to keep the formula constant.

The State Lottery revenues are paid each year according to the annual enrollment figures.

In the revenue account titled "Other State Revenue" the District has placed the estimated 2007-2008 revenue for part-time faculty compensation, health insurance, and office hours.

Local revenue figures reflect the projection of property taxes. This is a combination of property tax shift, homeowner's exemption, secured taxes, unsecured taxes, supplemental taxes, and prior years' taxes. The capital surcharge for non-resident students is shown in Fund 40.0.

General Fund Unrestricted Expenditures (01.0)

The expenditure projections reflect appropriate step, column and longevity increases for all qualified employees. Classified expenditures reflect the last offer made to the CSEA regarding salaries. The expenditures reflect the hiring of approved new faculty positions, replacement managers and administrators, replacement classified staff members, and new classified staff members to support the FTES goals of the college.

In the discretionary section of the expenditure budget (Supplies, Services and Capital) there was an increase in budget of approximately \$255,000 from 2006-2007. In 2006-2007 this increase was \$1,646,000 (excluding Compton related expenditures) over 2005-2006 and in 2005-2006 it was \$1,522,000 over 2004-2005. When we exclude mandatory increases to items such as insurance and augmentations made to conduct new programs such as the new Big Blue Bus transportation line, there was a decrease in requested budget for discretionary funds of \$238,000 from the 2006-2007 fiscal year. This decrease was accomplished through departments conducting meetings with staff and faculty and making voluntary reductions or voluntary transfers to other departments.

The Contracts/Services line item in the tentative budget includes: Rents/Leases (i.e. Madison Site, Swimming Pool, Big Blue Bus) 25%, Other Contract Services (i.e. Pest Control, Child Care Collaborative) 14%, Advertising (targeted to increase FTES) 12%, Repairs of Equipment 12%, Bank Fees and Bad Debt 7%, Postage and Delivery Services 6%, Legal Services (including Personnel Commission) 5%, Off Campus Printing 5%, Consultants 4%, Conferences and Training 3%, LACOE Contracts (i.e. PeopleSoft, HRS) 2%, Memberships and Dues 1%, Audit 1%, and Other Services (i.e. Software Licensing, Mileage, Professional Growth, Fingerprinting, Board Meetings, Field Trips) 3%.

RESTRICTED FUNDS

General Fund Restricted (01.3)

This fund represents restricted funding that is received by the District from Federal, State and Local sources. The restricted lottery revenue is by law allocated to the purchase of instructional materials. All grants that do not end by June 30, 2007 will be carried over to the 2008-2009 budget.

When received, new grants will be presented to the Board of Trustees for approval and the District's budget will be augmented to reflect the increase.

Special Reserve Fund (40.0) Capital

This fund is also known as the Capital Expenditures Fund. State funding for capital projects and required expenditure matches to State funding for scheduled maintenance/physical plant and special repair projects and architectural barrier removal are reflected in this fund. The non-resident capital charge is a revenue source to this fund. Those funds are used to cover the installment payments for the AET Certificate of Participation and any District required expenditure matches for scheduled maintenance/physical plant and special repair projects and architectural barrier removal.

Also included in this fund is the Earthquake Redevelopment Revenue from the City of Santa Monica for the replacement of the earthquake damaged Liberal Arts building. These funds are combined with State funds for the Humanities and Social Sciences Building Project.

All capital expenditures and revenue in the Special Reserve Fund, as well as Fund 41.0, Fund 42.1, Fund 42.2, and 42.3 reflect the total expenditure allocation and the total revenue for all projects, and are not limited to the current year, thus resulting in a zero ending balance. Money in these funds may not be transferred into the general fund.

Earthquake Fund (41.0)

This fund reflects the FEMA and OES funding received and expended as a result of the damage incurred at Santa Monica College due to the 1994 Northridge Earthquake. These funds are for the Liberal Arts Replacement (Humanities and Social Sciences Building) Project, the District's last earthquake project.

Bond Fund Measure U (42.2)

This fund reflects the revenue from the sale of bonds approved by Measure U and the interest earned in the fund. The expenditures in this fund relate to the College construction plan approved under Measure U.

Bond Fund Measure S (42.3)

This fund reflects the revenue from the sale of bonds approved by Measure S in November, 2004 and the interest earned in the fund. The expenditures in this fund relate to the College construction plan approved by Measure S.

Bond Interest and Redemption Fund (48.0)

This fund is administered by the Los Angeles County Treasurer's Office and reflects the receipt of property tax revenue due to voted indebtedness for bond issues and the payment of interest on those bonds plus the redemption of the bonds that mature within the 2007-2008 fiscal year. This information is provided by the Los Angeles County Treasurer's Office through the Los Angeles County Office of Education.

Student Financial Aid Fund (74.0)

This fund consists of all student financial aid programs (PELL, SEOG, EOPS and Cal Grants). Transfer line items reflect a transfer from the Unrestricted General Fund to meet the match requirements of the individual grant programs.

Auxiliary Operations

This budget reflects the revenue and expenditures of the auxiliary operations of the District, namely the bookstore, the food and vending concessions, and College expenditures in programs such as Athletics, Music, Theatre Arts, the *Corsair* student newspaper and transportation.

CONCLUSION

This is the recommended budget for acceptance. It reflects the best information currently available. It is expected that changes will occur between now and the Adopted Budget. Some changes will be the result of revised state revenue, and others will be internal adjustments resulting from new or updated revenue information and expenditure reduction efforts.
