 Individuals wishing to speak to the Board at a Board of Trustees meeting during Public Comments or regarding item(s) on the agenda must complete an information card with name, address, name of organization (if applicable) and the topic or item on which comment is to be made.

Five minutes is allotted to each speaker per topic. If there are more than four speakers on any topic or item, the Board reserves the option of limiting the time for each speaker. A speaker's time may not be transferred to another speaker.

#### General Public Comments and Consent Agenda

- The card to speak during Public Comments or on a Consent Agenda item must be submitted
  to the recording secretary at the meeting **before** the Board reaches the Public Comments
  section in the agenda.
- Five minutes is allotted to each speaker per topic for general public comments or per item
  in the Consent Agenda. The speaker must adhere to the topic. Individuals wishing to speak
  during Public Comments or on a specific item on the Consent Agenda will be called upon
  during Public Comments.

#### Major Items of Business

- The card to speak during Major Items of Business must be submitted to the recording secretary at the meeting before the Board reaches that specific item in the Major Items of Business in the agenda.
- Five minutes is allotted to each speaker per item in Major Items of Business. The speaker
  must adhere to the topic. Individuals wishing to speak on a specific item in Major Items of
  Business will be called upon at the time that the Board reaches that item in the agenda.
- 2. No uncivil or disorderly conduct shall be permitted at any Board of Trustees meeting. Persistence in displaying such conduct shall be grounds for summary termination and/or removal of the person from the meeting by the Chair.
- 3. No oral presentation shall include charges or complaints against any employee of the District, regardless of whether or not the employee is identified in the presentation by name or by another reference which tends to identify the individual. Charges or complaints against employees shall be submitted to the Board of Trustees under provisions of Board Policy Section 9421. Any employee against whom charges or complaints are to be made must be given 24 hours advanced notice and may request any such charges or complaints are heard in closed session.
- 4. Exceptions: This policy does not apply to individuals who address the Board at the invitation or request of the Board or the Superintendent.

Dr. L. Dee Fink, Director of the Instructional Development Program at the University of Oklahoma, will conduct a day-long workshop for instructional and counseling faculty. The workshop entitled "Designing Courses for More Significant Student Learning" will examine the role of course design in the overall act of teaching and will lead participants through a new way of designing courses, with a primary focus on the assessment of student learning and student outcomes. Cost is \$1,500 plus expenses, not to exceed \$2,700.

The 2001-2002 fiscal year closed with a combined General Fund ending balance of \$1,415,218 which is 1.2% of the total actual 2001-2002 combined General Fund expenditures of \$122,038,663. This is due to a negative prior year adjustment in apportionments of \$1,451,243 and the District's higher than budgeted cost of programs and services for our students.

#### **GENERAL FUND**

#### General Fund Unrestricted Revenues (01)

These are the only funds available for the general operations of the College. All other funds are restricted.

The federal income levels for 2002-2003 are projected at the 2001-2002 rate as notification has not been received regarding the 2002-2003 funding.

The State Community College budget has been projected to provide a 2% Cost of Living Adjustment (COLA) and an average state growth of 3%. These projections are based on the information received at the Chancellor's Office Budget Workshop. All of this information is subject to change when the actual budget for the State of California is passed by the legislature and signed by the Governor. For Santa Monica College the assigned growth CAP is 5%. However, the Chancellor's Office projection is that growth will only be funded at 70% of CAP.

The state funding formula is based on the combination of property taxes, enrollment fees and principal apportionment funds added together to equal the state revenue limit. The figures in the budget are based on projections from the Chancellor's Office. If actual receipts of either property taxes or enrollment fees exceed projections, apportionment funding will decrease to keep the formula constant. The enrollment fee remained at \$11 per unit for the 2002-2003 fiscal year.

The State Lottery revenues are based on the \$114 per 24,564 FTE projection from the State.

Partnership for Excellence (PFE) funding has not been increased since the Governor would not support the planned system-wide increase or the requested COLA to cover the rising cost of PFE programs. Thirty-two (32) faculty positions for over \$3 million, \$700,000 for part-time faculty and \$900,000 for instructional-related classified positions are funded from PFE dollars. In the income account titled "Other State Income" the District has placed the \$1,114,232 for part-time faculty compensation and \$205,874 for part-time faculty health benefits, the same as in 2001-2002. Both of these revenues are funded by the State from one-time revenue sources.

Local income items are projected to reflect the 2001-2002 actual figures. Parking fines have been projected to decrease due to the increased availability of parking in the new structure as we move toward our pre-earthquake parking capacity.

#### General Fund Unrestricted Expenditures (01)

The expenditure projections reflect the hiring of five (5) new faculty positions because of faculty separations during 2001-2002. A 2% COLA has been included for faculty salaries. The special state funded part-time instructor adjustment remains in the budget. No COLA is included in managers' and classified staff salaries. Appropriate step, column and longevity increases have been included for all qualifying employees. Health and Welfare Benefits have increased by 22%, Utilities by 11% and Postage by 10%. STRS contributions have increased to cover summer, winter and overload compensation as required under AB 2700. PERS contributions have been reinstated for 2002-2003 at a rate of 2.894% and a new PERS Safety Retirement Plan for college police has been implemented as agreed in the collective bargaining agreement with CSEA.

All cost centers were asked to reduce their discretionary budgets by 30%. The reductions were made in the classified hourly, supplies and contracted services areas. These reductions amounted to a reduction of \$2.8 million from the 2001-2002 adopted budget.

No building and site improvements are budgeted in the General Fund. The equipment expenditure budget reflects ongoing lease purchases and the District match for the instructional equipment grant.

The projected ending balance for fiscal year 2002-2003 is \$600,000. The ending balance could be affected by any adjustments to the State budget during the fiscal year.

#### **RESTRICTED FUNDS**

#### General Fund Restricted (03)

This fund represents restricted money that is received by the District from Federal, State and local sources. A summary of all grants is available in the Accounting office. The restricted lottery revenue is by law allocated to the purchase of instructional materials.

State funding reductions have caused major decreases in CalWORKS and Matriculation as reflected in this budget. All grants that did not end by June 30, 2002 have been carried over to the 2002-2003 budget.

When received, new grants will be presented to the Board of Trustees for approval and the District's budget will be augmented to reflect the increase.

#### Student Financial Aid Fund (09)

This fund consists of all student financial aid programs (PELL, SEOG, EOPS and Cal Grants). Transfer line items reflect a transfer from the General Fund Unrestricted to meet the match requirement of the individual grant programs.

Since our default rate has fallen to an all-time low of 5.3%, we will not be subject to any Federal penalties that could result in a reduction in allocations. Additional allocations for fiscal year 2002-2003 will be augmented to the Adopted Budget by Board of Trustee's action when awards are received and approved.

#### Special Reserve Fund (15) (Capital)

This fund is also known as the Capital Expenditures Fund. State funding for capital projects, scheduled maintenance, asbestos abatement and architectural barrier removal is reflected in this fund. The non-resident capital charge is a revenue source to this fund. This fund includes two State funded capital projects, the Library Addition and the equipment for the Library Addition.

Also included in this fund is the Earthquake Redevelopment Revenue expected from the City of Santa Monica for the replacement of Parking Structure B and the Liberal Arts building. These funds will be used to pay the capital debt incurred to finance the parking structure and as matching funds for the Liberal Arts project.

All capital expenditures and income in the Special Reserve Fund, as well as Fund 70, Fund 71 and Fund 73 reflect the total expense allocation and the total income for all projects and is not limited to current year, thus resulting in a zero ending balance.

#### Bond Interest and Redemption Fund (21)

This fund is administered by the Los Angeles County Treasurer's Office and reflects the receipt of property tax money due to voted indebtedness for bond issues and the payment of interest on those bonds plus the redemption of the bonds whose maturity date is within the 2002-2003 fiscal year. This information is projected for the District by the Los Angeles County Treasurer's Office.

#### Bond Fund Prop T (70)

This fund reflects the revenue from the sale of bonds approved by Proposition "T" and the interest earned in the fund.

The expenditures in this fund are coupled with Fund 15 State Grants and Fund 73 FEMA funding to cover the necessary expenses related to the College construction plan approved under Prop T. The Library Project is the major remaining project scheduled for completion in August of 2003.

#### Bond Fund Measure U (71) [New Fund to be Used for all Measure U Income & Expense]

This fund reflects the revenue from the sale of bonds approved by Measure U and the interest earned in the fund.

The expenditures in this fund relate to the College construction plan approved under Measure U.

#### Earthquake Fund (73)

This fund reflects the FEMA and OES money received and expended as a result of the damage incurred at Santa Monica College due to the 1994 Northridge Earthquake.

#### **Auxiliary Operations**

This budget reflects the income and expenses of the auxiliary operations of the District, namely the bookstore, the food and vending concessions, and College expenses in programs such as athletics, music, theatre arts, THE CORSAIR and transportation.

The prior year adjustment is to reconcile the inventory accounting with the audit statements (\$1,131,658) for the overage carried in the retained earnings. The past methodology gave the incorrect perception that there were additional funds in the auxiliary fund. The balance of the adjustment is to write off bad checks and student charge sales.

#### CONCLUSION

At the time the 2002-2003 Adopted Budget for the District was prepared, the State did not have an Adopted Budget. Therefore, the projected revenues are based on the Chancellor's Office projections and could change substantially when a final State budget is approved. Those changes will be presented to the Board of Trustees for approval as budget augmentations or decreases.
