IV. Reports/Discussion

a. Governor's January Proposal and 2nd Quarter Budget Update – Chris Bonvenuto shared the highlights from the Governor's Budget. 18 months ago, California was looking at a \$54.3 billion shortfall. Today, California has a \$45.7 billion surplus. Noted Concern: The Economic Forecast was pre-omicron, it could affect January Budget figures. The District is at beginning of the state budget process, May Revise follows, then June adoption. Things can and will change.

Community College System: \$841.5 m ongoing funds. Major Items: CCC Apportionment-increase of \$434.3 m Proposition 98 General Fund, Part-Time Faculty Health Insurance, Augmentations for Student Success Completion Grant, Deferred Maintenance, CCC Retention and Enrollment Strategies.

2nd Quarter Budget: Major Items of Note: Deficit Factor <1.03%> or <\$1.497>m, FTES projections, Resident FTES <10.074%> or <1,924> also Non-resident FTES <14.786%> or <456.6>, decrease since 2017-19 of ~<\$13,248,335> or <39%>. The projected changes in Revenue, Expenditures, Fund Balance from 2021-2022 Adopted Budget to Second Quarter Projections were discussed. Chris Bonvenuto stated that SMC is firmly a "Medium-Sized District". The good news is Governor Newsom is proposing Hold Harmless to become permanent with legislation being finalized, which will put the district in a better fiscal situation.

Chris Bonvenuto covered the District's 5 Year Multi Year Budget Unrestricted General Fund – Five Year Projections, Fiscal Years 2019-20 through 2025-26, FY 2021-22 Projected Q2 – major changes is the ONE-TIME HEERF funding disappears in Fiscal Year 2022-2023.
