1. Student Centered Funding Formula Allocation Calculator

Chris shared the Student Centered Funding Formula (SCFF) Allocation Calculator to show past and future changes in funding allocation for the district in the upcoming years. Funding in many metrics are based on a 3 year average. The following allocations were discussed: Base Allocation FTES, Supplemental Allocation (AB 540, PELL, Promise), Success Metrics (AS for Transfer, AD, BA Granted, Certificates, Transfer Level Math and English, Transfers to Four-Year University. Under Hold Harmless we received additional funds for COLA, which the district will no longer receive in 2025-2026 when the district moves to the Student Centered Funding Formula (SCFF).

The Committee also reviewed the Unrestricted GF- Five Year Projections Fiscal Years 2023-24 thru 2028-29.

- 2. <u>Budget Planning</u> suggestions on reducing the projected ~\$15.493 million deficit in the 2025-26 fiscal year. The following ideas were discussed:
 - 1. Closing the college certain numbers of days a week. Possible savings of \$480,000 to \$980,000
 - 2. Sell 2714 Pico and move staff to campus Question: Can sale go to Unrestricted Fund?

- 3. Faculty banking hours in summer instead of payment *Requires negotiations and discussion with Academic Affairs
- 4. Malibu campus: Is there way to lessen costs?
 - *Close college for part of the year?
 - *Way to run more efficiently?
- 5. If not filling positions we need to train technology, payroll, and budget, to increase efficiency especially as positions are not hired.
- Restructure as people leave.Do exit interviews to find out what the person leaving had done
- 7. Suggestion: Amount is large and need to have Administration to lead conversation for large changes with each constituency group
- 8. Suggestion: Organizational Plan that looks at efficiency especially if staffing changes. Make clear expectations change when staffing changes
- 9. Savings: Review initiatives and reallocate resources toward core services.
- Restructuring is at the core of concern for all groups.
 Group wants to know from Administration what the steps are

The Budget Committee made the following recommendation:

While the Budget Committee waits for the Superintendent/President and Senior Staff to address the projected ~\$15.5 million deficit, the Budget Committee will work on guiding principles to inform budgetary cuts and decisions.
