2. Annual Action Plans 2025-2026

#### Climate Action Plan # 1 Annual Action Plan

Ferris Kawar, Director, Sustainability, attended the meeting and answered questions regarding the request for \$13,000 (one-time request of unrestricted funds) to hire an experienced consultant to assist completing the Climate Action Plan. The consultant will edit the draft, make text revisions, improve alignment between topics, verify calculations and protocol consistency, identify performance indicators and collaborate with staff.

#### Recommendation:

The Budget Committee reviewed the DPAC Annual Action Plan # 1 and recommends the Climate Action Plan to DPAC and Dr. Jeffery as presented, for considerations of inclusion in the 2025-2026 District Budget.

### Campus Safety Culture #2 Annual Action Plan

Michael Tuitasi, VP, Student Affairs and Daniel Phillips, Director, Safety and Risk Management attended and answered questions on behalf of Chief Adams and Captain Kilgore who were unable to attend.

The goals of the Campus Safety Culture Action Plan are to develop tailored training programs, improved Emergency Communication, Create a Clear Safety Plan, Tabletop Exercises, Continuous Training to implement a culture of safety, workplace violence prevention, and deal with earthquake and chemical emergencies.

#### The Budget Committee expressed the following concerns related to the proposal:

Establish a new "Emergency Preparedness Manager": The committee had questions regarding the duties, responsibilities, and whether the current Captain should be performing these duties. Also, the committee notes the District is in a hiring freeze where only vital positions will be hired.

Review by SMC Emergency and Safety Committee: Several members of the budget committee would like the SMC Emergency and Safety Committee to review and provide feedback on the Campus Safety Culture - Annual Action Plan # 2.

The Budget Committee will invite Chief Adams and Captain Kilgore to the May 7<sup>th</sup> meeting for follow up questions and continued discussion of the Annual Action Plan # 2 – Campus Safety Culture.

The Budget Committee meeting on April 16, 2025 is canceled due to spring break.

The next meeting will be held on April 30, 2025 for the 3<sup>rd</sup> Quarter Budget Presentation Update.
