IV. Reports/Discussion

On May 10, 2024, Governor Newsom presented the May Revise.
 The state has a projected \$44.9 billion deficit in FY 24-25 and an additional \$28.4 billion deficit in FY 25-26. The governor enacted an Early Action Plan and cut \$27 billion through reductions, borrowing, deferrals and funding shifts. There were no significant budget cuts to community colleges and Proposition 98 level funding was maintained. Cost of Living Adjustment (COLA) went up from 0.76% to 1.08%.

The Governor's office has not released the full financial data as in previous years. Chris Bonvenuto will give an update once the Governor's office releases all the data in the coming months.

Chris shared: Unrestricted GF – Five Year projections Fiscal Years 2022-2023 through 2027-2028. The District is facing increasing deficits over the next three years.

2. 2024-25 Annual Action Plan

The Budget Committee was presented with the following annual action plan:

"Identify the retention and persistence components of existing college plans and activities (e.g., Strategic Enrollment Management (SEM) Plan, Student Equity Plan, Guided Pathways, Facilities Master Plan, Professional Development, Onboarding), develop recommendations on how to improve coordination of the plans and develop recommendations on how to assess the annual impact of each plan on retention and persistence."

The lead person(s): Michael Tuitasi, Vice President, Student Affairs and Jason Beardsley, Vice President, Academic Affairs. There is no fiscal impact to the district as SMC staff and faculty will work on this plan.
