IV. Reports/Discussions Chris Bonvenuto presented the May Revise and Tentative Budget 2022-2023

- a. May Revise 2022-2023: \$49.2 Billion discretionary 3 Year Surplus. Apportionment 6.56% COLA, Part-Time Faculty Support-no change from January proposal, Student Enrollment and Retention-no change from January proposal, Student Success Completion Grants-\$50 million ongoing, Expanding Student Support Programs & Strengthening Academic Pathways, Workforce and Diversity, Technology Modernization-improve technology infrastructure and prevent cyber-attacks, Physical Plant and Instructional Equipment, Discretionary Block Grant \$13.8 million for SMC. Chris Bonvenuto highlighted that no one can predict a recession, however recession indicators are rising, and there are also concerns with GANN Limit.
- b. Tentative Budget 2022-2023 (Allows for operations from July 1 and Adopted Budget- September)
 Apportionment (State Funding) = 2021-2022 level with 6.56% COLA, COLA \$9,497,269
 Use of HEERF to Backfill Lost Revenue: \$0, in 2021-2022: \$13,068,911
 Credit Resident Decline <8.0%> or <1,373.93> FTES, <19%> or <3,703> less CR FTES than 2018-2019
 Non-resident Enrollment Decline <0%> or <0> FTES, since 2018-2019 <1,492> or <35.0%> decline

Projected Changes in Revenue

2021-2022 Projection to Tentative Budget = Decrease in Revenue ~<\$2.893> million

Projected Changes in Expenditures

2021-2022 Projection to Tentative Budget = Increase of \$663,674 or 0.34%

Fund Balance

Budget is balanced structurally and operationally-great news.

Board can allocate up to \$1.4 million additional on-going expenditures
