### IV. Reports/Discussion

a. Adopted Budget Review – Chris Bonvenuto shared 2022-2023 Summary of Changes from Tentative Budget Projections

<u>Apportionment</u>: 8.22% COLA, Estimated \$12,681,216 for SMC, SMC is in hold harmless (\$166,953,920). Starting 2025-2026 Districts will receive funding under SCFF, or the amount of funding received in 2024-2025 whichever is greater. Hold Harmless Districts will no longer receive COLA starting in 2025-26.

<u>Student Enrollment and Retention:</u> The State Budget included a systemwide retroactive reduction of 2022-2023 funding of <\$55.4> million and a new allocation in 2023-2024 of \$50 million for a net systemwide decrease of <\$5.4> million.

Physical Plant and Instructional Equipment: The State Budget included a systemwide retroactive reduction of 2022-2023 funding of <\$500> million and a new allocation in 2023-2024 of \$5.4 million for a net decrease in funding of <\$494.6> million. For SMC this is a reduction of <\$9,555,621> leaving \$6,509,922 for scheduled maintenance and instructional equipment. Inclusion of Annual Action Plans: DPAC continued 2 Annual Plans from 2022-2023 into 2023-2024. These plans have been included in the proposed budget for a total of \$600,750.

Major Assumptions – Apportionment (COLA 8.22% or \$12,681,216), CrFTES growth 3.0% or 482 FTES, Non-resident FTES: 7.0% or 199 FTES, Salaries, Health and Welfare, Utilities adjusted for increased usage, Insurance and the budget does not contain a budget for equipment. Budget reductions approved by the Budget Committee have been included in the budget with one major change: Due to the short turn around the Fall schedule will not be able to achieve 100% efficiency so, savings is based on an adjusted annual 92.5% efficiency assumption.

The District will be able to pass a budget in 2024-2025 with the State recommended minimum fund balance of 5.0% assuming all assumptions in the proposed adopted budget are accurate.

The Budget Committee will work on long term fiscal planning for 2024-2025.
