Projected Changes in Expenditures 2021-2022 Unaudited to 2022-2023 Proposed Adopted Budget-Total increase in Expenditures \$8,525,526 or 4.40%

Projected Changes in Fund Balance 2021-2022 Unaudited to 2022-2023 Proposed Adopted Budget Deficit Fund Balance amount: <\$2,728,805>
