2. Fiscal Services Update

Chris Bonvenuto gave a brief budget update on the State financial status. He shared the status of some key economic indicators, such as a decline in January's cash receipts, the growth of the unemployment rate, and a decrease in building and construction permits of 10.6% from the prior year. The key economic indicators are signaling that the State financial situation may not be as strong as was previously indicated.

An update was also given on the California Community College Chancellors' Office release of the P1, which is the first funding update colleges receive from the CCCCO since the beginning of the fiscal year. The P1 is a projected a ~1.5% to 7.2% deficit factor, for Santa Monica College this would mean a possible one-time reduction in current year revenue \$2.5 million to \$12 million.
