#### V. Annual Audit - Update

Chris Bonvenuto informed the committee that the auditors had completed the on-site portion of the audit, but their report was not complete. The preliminary results are very favorable, with very few audit findings. Most of the findings are due to new reporting practices from the state.

Summary of what happened to the State's \$ 4 billion dollar was distributed (revised budget as of November 2007 is -\$ 1.874 million). This report provides economic indicators to help clarify figures. Chris pointed out that although SMC has a large reserve at this time, once the one time money goes away, our reserve will decrease very quickly.
