IV. Agenda:

A. 2012-2013 Adopted Budget

Chris Bonvenuto shared the 2012-2013 Adopted Budget and answered all the questions posed by the Committee. The Adopted Budget shows \$134.8 million in revenue and \$138.8 million in expenditures. The Adopted Budget is based on the State budget and assumes the passage of Proposition 30, no growth funding, no COLA and no deficit factor. The District is planning on serving 250 unfunded FTES and reduce the class schedule to meet this target, thereby saving \$1.7 million in expenditures compared to last year. The District intends to serve 20,254 Credit FTES, 533 Non-Credit FTES, 154 CDCP Non-Credit FTES and 4185 Non-Resident FTES which in total is the smallest amount of FTES served by the College in the past 5 years.

Information about the District Vacancy List was shared, showing 3 Fund 1.0 (General Fund) Administrators positions, 14 Fund 1.0 (General Fund) Classified positions and 2 Fund 1.3 (Restricted Fund) Classified positions. Information about 5000 series

Contracts and Services accounts was shared, showing an adopted budget of \$10.9 million for these expenses in 2012-2013.

The 2012-2013 Adopted Budget shows an Ending Fund Balance of \$8.8 million with \$2.267 million in Designated Reserves as well as an Operating Deficit of \$4 million.
