IV. Agenda:

A. Review of Contracts and Services

Vice-President Isomoto shared information with the Committee regarding the District's Contracts and Services (5000 Series). Various questions were posed by several committee members. Further information was requested regarding Bad Debts-Student Fees, Advertising, Off Campus Printing, Managed Printing Services, Transportation-Others and Other Contract Services. Vice-President Isomoto agreed to bring back further information at an upcoming meeting.

Following all the discussion, the following motions were made:

MOTION: "The Budget Committee recommends that DPAC analyze the cost and use of the printed and mailed class schedule to reduce our environmental impact and save money."

MOTION PASSES

Committee members asked that Vice-President Rodriguez present information regarding current enrollment policies that are contributing to Bad Debt costs to see if changes might be made that can save money. Committee members also asked that Don Girard present information regarding the types of advertising and marketing campaigns that are being undertaken by the college as well as any effectiveness data regarding them. Co-Chairs agreed to invite these individuals to an upcoming meeting.

B. State Budget Update

Governor Brown signed the bill authorizing up to \$100 million to backfill any RDA shortfall identified by the Department of Finance. While both the Department of Finance and the Chancellor's Office seem to agree that the shortfall is approximately \$88 million, the Department of Finance is still calculating exactly what part of the shortfall it will backfill. The Adopted Budget assumed \$1.4 million would be backfilled. It will likely not be until late November or December that the Department of Finance will release its estimate of the portion of the deficit it plans to backfill.
