# IV. Agenda:

## A. Report Regarding Student ID Fee

Vice-President Isomoto shared information regarding the revenue generated from the Student ID Card Fee. For fiscal year 2011-2012, it generated \$994,960. For fiscal year

2012-2013, it generated \$975,915 For fiscal year 2013-2014, it is projected to generate \$963,343. For fiscal year 2014-2015, it is budgeted to generate \$993,000.

Don Girard and George Prather provided historical context for the past 20 year period when ID cards have been in place at Santa Monica College. At the present time, \$19.50 is charged for Associated Students membership and \$13 is charged for the Student ID Card fee. The Student ID Card fee supports various campus services and allows students to utilize the Library, access supplemental instruction such as the tutoring centers, as well as language and computers labs. In a recent electronic survey of students, 45% of responding students use public transportation to get to Santa Monica College

Vice-President Tuitasi and Rodriguez reported that, although in practice these two fees do not work well independently, these two fees are not linked and students can be opt out before the census date of either one or both fees.

Following much discussion, the following motion was made and seconded: MOTION:

"The Budget Committee recommends to DPAC that the District separate the Associated Student fee from the Student ID Card fee."
