- IV. Discussion Chris Bonvenuto presented the following:
 - a. Budget Update highlighting differences between Governor and Senate's proposed funding. The Governor is showing cuts in the current budget, whereas the Senate is choosing to defer funding in case the federal government passes a legislation aid package in the coming months.
 - b. Multi Year Budget, Unrestricted General Fund-Fiscal Years 2017-2018 thru 2022-2023, Five Year Projections shared with proposed reductions. Currently, there is an additional \$13,000,000 deficit. The tentative budget is due June 30, 2020.
 - c. Chris Bonvenuto announced SMC was awarded a one-time \$800,000 subgrant within the CARES Act. Budget Committee will discuss ideas on where the money will be allocated.
