An update in 2010-11 resulted in the addition of two new initiatives GRIT and the Institutional Imagination initiative (I-Cubed). A request for proposal has been forwarded to potential consultants to assist the college with this planning process. A Strategic Planning Task Force will be created, and it was suggested that two representatives from each constituency group be appointed to the task force. A smaller group will be asked to review the proposals and make a recommendation to the Superintendent/President. The process can begin immediately following the selection of the consultant and continue through the end of the academic year.
