 - 1. Medical Changes 81, mostly switches to Blue Shield
 - a. 52 Changes to Blue Shield
 - i. 23: Full-Time Faculty
 - ii. 1: Academic Administrator
 - iii. 27: Classified Employees
 - iv. 1: Personnel Commission or Board of Trustees
 - b. These changes are higher than the average.

- 1. Long-Term Care Insurance Update
 - i. This enrollment was successful.
 - 1. Enrolment Period: 10/30/2023 to 12/15/2023 (was extended)
 - Inquiries: 138 (YourCare 360, Webinar Attendee, Phone, Direct Mail Return Card)
 - 3. Applications: 55
 - a. Average Face Value Amount: \$113,203
 - i. \$4,528 long-term benefits for up to 25 months
 - ii. A new enrollment period can be held in Fall 2024 for new hired only.
 - iii. A simplified enrollment period can be held for all employees every two years (medical history will be considered), with the next one in 2025.
 - iv. If the Long-Term Care Taxation passes, a simplified enrollment period can be held for all employees.
 - v. Is the committee interested in continuing to offer simplified long-term care every two years? (it is no cost to the District and a benefit to the employee)
