






Enrollment and Nationalities

- 94 different countries

Benefits of Serving International Students

Cultural Benefits

- Enrich classrooms and college activities with diverse ideas and cultural perspectives
- Academic Excellence International students have exceptional transfer rates to top colleges, helping SMC to remain #1 in transfers to UCs, CSU, USC, & LMU
- International students have made SMC a global brand
- Active participants in campus life and student governance

Financial Benefits

- International students contribute \$39 billion to the national economy and support more than 400,000 jobs across the U.S.
- International students pay non-resident tuition roughly 8 times as much as domestic students (\$386/unit vs. \$48/unit)
- International tuition is SMC's 2nd largest revenue stream
- Revenue from international tuition is used to support services, faculty/staff hires, and campus events for ALL students



What's Different for F-1 Visa Students? Regulations and Challenges

What is an F-1 Visa?

- Visa that allows non-U.S. Citizens to enter the U.S. with the intent of being a fulltime student
- Students apply for the F-1 visa through U.S. Embassy or Consulate, usually in their home country
- Most SMC F-1 visa applicants are given an I-20 that allows them to study for up to 7 semesters.



Major Differences for F-1 Students



Application Process

Apply early to get an I-20 and apply for F-1 visa

Application fee (\$75) and Seminar fee (\$85)

Must submit extensive admission documentation and attend mandatory online Information Seminar



Tuition & Fees

SMC's 2nd largest revenue source

Pay 8x more in tuition than residents: \$386/unit

Estimated annual expenses: \$29,000



Employment Options

Only eligible to work offcampus in specific situations

Must receive authorization to work off-campus

Only eligible for Student Help jobs on-campus

Major Differences Continued



Full-Time Enrollment Requirement

Enrollment in fewer than 12 units is an F-1 Status Violation!

Consequences of Grading Decisions: "F" vs. "W"



On-ground/hybrid Class Requirement

International Students MUST take at least 9 units on-ground/hybrid to maintain F-1 visa status

No more than 1 online 3 units course can count towards the mandatory 12 units enrollment requirement

Consequences of Status Violations for Students

When international students violate their F-1 status, they must:

- 1. File for reinstatement of their status with USCIS, an expensive and time-intensive process, or
- 2. Leave the U.S., pay a \$350 fee for a new I-20, potentially apply for a new F-1 visa, and attempt to re-enter the U.S. or,
- 3. Leave the U.S. and abandon their studies

Falling out of status is bad for students, and bad for SMC!

Consequences of Lack of On-Ground/Hybrid Classes for Students and the College

- About 100 international students have not enrolled in the onground/hybrid classes needed to maintain F-1 status due to lack of availability
- Lack of on-ground/hybrid courses forces students to enroll at other institutions or fall out of status and withdraw from SMC completely
- Loss of tuition for a single 3-unit class for 100 students = -\$115,800 for one semester
- Loss of 100 students due to Withdrawal from the college =
 -\$1,852,800 over 2 years

External Challenges

- Demographic decline of college aged students across major recruitment markets
- Increased competition from UK, Australia, Canada, and New Zealand: Increased availability and ease of applying for visas, pathways to residency after education, and employment opportunities
- COVID-19: Embassy closures, travel bans and restrictions,
- Hostile domestic political rhetoric Feeling unsafe and not wanted
- Difficult F-1 visa application process and increase in visa denials

Internal Challenges

Student-Specific:

- Difficulty understanding how to navigate college and immigration requirements, asking for help, finding resources
- Homesickness, culture shock
- Issues in home country (medical, financial, political)
- Housing & Transportation

College-Wide:

- Lack of sufficient on-ground/hybrid class options
- Students going under unit and falling out of F-1 status

IEC Services

Front Desk

- Answer all F-1 student questions in person, phone, email, Hubspot "triage"
- Mass email reminders and updates, flyers & brochures, assist with Seminars

Admissions

- Provide individual admissions support through international application portal
- Create initial I-20s and register continuing students in SEVIS
- Complete verification letters and I-20 travel signatures

Specialists

- Immigration, Admissions, Housing, Health Insurance, Student Events & Activities
- Intensive English Program
- Social Media: Instagram <u>smc_international</u>

IEC Services Cont'd

IEC Counselors

- All regular counselor duties
- Recommend students for RCLs, Concurrent Enrollment, and post-completion work authorization
- Notify and advise students who are not enrolled in sufficient on-ground/hybrid classes
- Assist students in finding classes at SMC or other schools that meet program and immigration requirements

Immigration Team

- Share immigration regulations with new students in the Information Seminar
- Determine student eligibility and assist students with applications for F-1 Benefits
- Alert students who are under units and at risk of falling out of status
- Meet with students to address immigration related questions
- Assist students with reinstatement e.g., explaining regulations, writing letters, helping with forms
- Review off-campus work or internship requirements, assist with applications
- Create information-sharing videos on relevant topics
- Coordinate presentations on taxes and post-completion options

IEC Retention & Engagement Strategies

- Proactively connect students to employment, academic, mental health/welness, food programs and support services
- Develop and implement on-ground engagement activities
- Expand database of affordable housing options
- Work with counselors to identify new students that would benefit from Reduced Course Load (RCL) approval
- Work with Academic Affairs to create faculty-led workshops designed to increase faculty awareness of international student needs

How Can You Help?

- 1. Clearly communicate class attendance policies/Drop Policies
- 2. Know the basic regulations:
 - a. 12 units enrollment requirement
 - b. Implication of late semester drops
 - c. Grade implications (letter Grade A-F Vs. W)
- 3. Be aware of who international students in your classes are and acknowledge them on the first day of class
- 4. Encourage international students to contact the IEC any time they need help
- 5. Flag students in GPS
- 6. Advocate for more on-ground or hybrid class sections
- 7. Reach out to the IEC any time you have questions about an F-1 visa student, or you think a student could use some additional support or resources
