Racial Illiteracy

- "When we say equity, we really mean supporting all students."
 - o this is not the way to understand equity goes back to universalist thinking
 - o Equity is corrective justice, anti-racism, decentering whiteness
- "Equity-mindedness is the lens. Closing achievement gaps is the goal."
 - Equity-mindedness has a specific definition not related to achievement gaps
 - Achievement gaps is the opposite of equity-mindedness
 - leads to a deficit-mindedness of Black and Latinx students by viewing them through a lens of poverty of culture
- Racial illiteracy can do more harm to students

Disaggregating data

- We need to go deeper beyond institutional-level and discipline-level
- It is useful to examine instructor-level data to analyze how classrooms are racialized
 - it is a starting point for inquiry does not prove or disprove that an instructor is equitable or inequitable
- why do our classrooms reproduce racial equity gaps?
 - o policies?
 - o assessments?
 - o teaching practices?

Engaging in Race-Conscious Inquiry

What does it mean to be racialized

- especially for students and how instructors can engage with students
- Lean into the discomfort of having race conscious discussions
 - avoiding the discomfort could be related to whiteness

What does it mean to be an equity-minded instructor/practitioner?

- we need to accept that all of us in higher-ed have not been taught to be race-conscious
 - we are first-gen equity practitioners
- we have to learn to be critically race conscious
- Don't be color-blind
- interrogating how your identity impacts students' relationships with you
- Racial equity means corrective justice for the historical exclusionary and harmful practices, anti-racism
 - doing more for those who have the greatest needs
